- 1. MAYOR TESKE CALLED THE MEETING TO ORDER AT 7:00 P.M. AND ANNOUNCED A QUORUM PRESENT.
- 2. MAYOR TESKE LED THE RECITATION OF THE PLEDGE OF ALLEGIANCE AND DELIVERED THE INVOCATION.
- 3. EXECUTIVE SESSION

At 7:03 p.m., in accordance with Texas Government Code, Chapter 551, Subchapter D, Mayor Teske recessed the meeting to go into Executive Session (closed meeting) to discuss the following items:

- a) Section 551.074 Personnel matters to deliberate the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee; or hear a complaint or charge against an officer or employee regarding Mayor and City Council appointments in the event of resignations and vacancies.
- b) Section 551.071(1),(2) Consultation with Attorney to seek the advice of the City Attorney about pending or contemplated litigation; or a settlement offer and on a matter in which the duty of the Attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Public Information Act:
 - i. Vacancies in the Office of Mayor and City Council, including appointment process;
 - ii. Memorandum of Understanding with Nevada Volunteer Fire Department and agreement for fire protection services; and
 - iii. Options for fire services, including establishing a volunteer fire department for the City.
