4. CITIZENS COMMENTS

Todd Graham, ETJ Resident requested clarification on how disannexing from the ETJ affected the ESD?

Ms. Dobbs responded that the "Fire District" was different than the ETJ and disannexing would not affect service to those properties.

5. PRESENTATION

Mike Ward, CPA, Accounting & Financial Consulting, PLLC presented the audited 2024 Financial Statements and Independent Audit Report. Mr. Ward stated that the audit resulted in an unmodified ("clean") opinion indicating that the financial statements are presented fairly, in all material respects, in accordance with generally accepted accounting principles and added that this represents the best opinion possible. Mr. Ward reviewed the statements and acknowledged overall net growth in the City's funds and strong, stable financial position.

7. ITEMS FOR CONSIDERATION

A. Discussion and action regarding Resolution No. 2025-03-02 awarding the construction project bid for the City of Lavon Rosewood Dr. Paving Reconstruction (CIP-35) and CR 484 Paving Reconstruction (CIP-11) and approving and authorizing the negotiation and execution of a construction contract with DDM Construction Corporation in an amount not to exceed \$1,916,410.00 with 153 days to construct.

City Manager Kim Dobbs provided information and City Engineer Erin Magee, Freeman Millican detailed the project. Ms. Dobbs noted that the Rosewood construction project is intentionally timed to coincide with the summer break for the schools. ETJ Resident Rick Mann asked if sidewalks along Cr 484 would be included in this project, Ms. Magee added that sidewalks were not in the scope of this initial construction.

Ms. Dobbs provided information about the MDD Bylaws and City Attorney, Julie Fort, Messer, Fort Municipal Law Firm, detailed the proposed bylaws and answered questions. ETJ Residents Todd Graham and Cindy MacArthur posed questions regarding the MDD and Ms. Fort responded.

City Council directed staff to prepare a Resolution for the proposed draft bylaws for the March 18, 2025 meeting.

C. Discussion and action regarding Ordinance No. <u>2025-03-08</u> to amend Chapter 12, "Utilities", of the Code of Ordinances by amending Article 12.06 "Grease Traps" relating to the installation and maintenance of new non-residential systems; and providing a penalty.

Ms. Dobbs provided information about the amendment of Chapter 12 of the Code of Ordinances in regard to "Grease Traps".
