A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAVON, COLLIN COUNTY, TEXAS, CANVASSING THE RETURNS, INCLUDING THE RETURNS OF EARLY VOTING BALLOTS CAST IN CONNECTION THEREWITH, AND DECLARING THE RESULTS OF THE GENERAL ELECTION OF THE CITY OF LAVON HELD ON NOVEMBER 5, 2024, FOR THE PURPOSE OF ELECTING CITY COUNCILMEMBERS FOR PLACE NOS. 1, 3 AND 5 FOR TWO-YEAR TERMS; AND PROVIDING AN EFFECTIVE DATE.
