AN ORDINANCE LIMITING THE ACCESS OF GRACY LANE IN THE CITY OF LAVON, COLLIN COUNTY, TEXAS; PROVIDING FOR A PUBLIC HEARING; AND AUTHORIZING THE CHIEF OF OPERATIONS TO INSTRUCT THE PUBLIC WORKS DIRECTOR TO ERECT THE NECESSARY BARRICADE TO FACILITATE THE LIMITED ACCESS.

WHEREAS, the City of Lavon, Collin County, Texas is an incorporated municipality operating under the general laws of this State; and

WHEREAS, V.T.C.A. Transportation Code Section 311.008 authorizes any such city or town to vacate, abandon and close any street or alley upon a petition of all of the abutting owners on said street or alley; and

WHEREAS, the attached Petition constitutes all of the abutting owners on both sides of that certain street described as Gracy Lane lying and being between Main Street and FM 2755 (McClendon Road), in said City, as more fully shown by the S. M. Rainer Survey ABS A0740 Block 2 Tracts 38, 85, 98, 99, 100, 101, 102, and 126.

WHEREAS, the said owners have petitioned the City Council to limit the traffic access on the south entrance of Gracy Lane at FM 2755 (McClendon Rd.); and

WHEREAS, the said City Council called a public hearing on the proposed limiting access of said street to be held in the Council chamber at the City Hall on the 16th day of October, 2012, of which due notice was given by publication one (1) time in *The Wylie News*, a newspaper of general circulation in the City on the 26th day of September, 2012, and said public hearing was held on the day stated in said notice; and

WHEREAS, the said City Council finds and declares that it is in the best interest of all of the citizens of the City of Lavon that said Gracy Lane have limited access.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAVON, COLLIN COUNTY, TEXAS:

Section 1. All of the certain street described as Gracy Lane lying and being situated between Main Street and FM2755 (McClendon Rd.), will hereby have limited access by way of closing the south access to Gracy Lane from FM2755 (McClendon Rd.).

Section 2. Attached to this ordinance is the petition by landowners requesting the limited access.

Section 3. Also attached is a map from the Collin County Interactive Website that shows the properties along Gracy Lane.

Section 4. The Chief of Operations is hereby authorized and directed to instruct the Public Works Director to erect the necessary barricade(s) and signage to safely facilitate the limited access of Gracy Lane.
