# CITY OF LAVON, TEXAS ORDINANCE NO. 2018-03-01

Amending the Code of Regulations Relating to Parks and Recreation Board

AN ORDINANCE OF THE CITY OF LAVON, TEXAS AMENDING TITLE 3, ADMINISTRATION, SUBTITLE 3 COMMITTEES AND COMMISSIONS, CHAPTER 9 PARKS AND RECREATION BOARD OF THE CITY OF LAVON CODE OF REGULATIONS REGARDING THE STRUCTURE OF THE PARKS AND RECREATION BOARD; PROVIDING SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Lavon has previously adopted the City of Lavon Code of Regulations; and

WHEREAS, the City Council believes it is in the best interest for the City of Lavon, its citizens and visitors to amend the City of Lavon Code of Regulations relating to the structure of the Parks and Recreation Board;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAVON, TEXAS, THAT:

### SECTION 1. AMENDING THE CITY OF LAVON CODE OF REGULATIONS

The City Council of the City of Lavon does hereby approve the following amendments to the <u>City of Lavon Code of Regulations Title 3 Administration, Subtitle 3 Committees and Commissions, Chapter 9 Parks and Recreation Board.</u>

- 1.1 Delete and replace Section 3.3.9.2 Structure of Parks and Recreation Board as follows:
- "3.3.9.2 Structure of Parks and Recreation Board
- A) The Parks and Recreation Board shall consist of five (5) regular members and one (1) alternate member appointed by the City Council.
  - 1) The regular board members shall be organized by numbered seats (1-5).
  - 2) The alternate member shall be designated as the First Alternate.
- B) The Chair shall be selected as described in Section 3.3.9.5 and shall be authorized to vote.
- C) The alternate board member shall be authorized to vote on any matter when the alternate member's presence forms the quorum.
- D) The City Council shall select from its membership a Liaison to serve as regular member of the Parks and Recreation Board.
- E) The officers of the Parks and Recreation Board shall be:
  - 1) Chair
  - 2) Vice Chair.

- 1.2 Delete Section 3.3.9.5 <u>Selection of Officers for the Parks and Recreation Board,</u> Subsection D).
- 1.3 Delete Section 3.3.9.20 <u>Duties of Board Secretary</u>.
- 1.4 Delete Section 3.3.9.23 <u>Duties of the Operations Division Liaison to the Parks and Recreation Board."</u>

# SECTION 2. SEVERABILITY CLAUSE

In the event any clause, phrase, provision, sentence, or any part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provisions hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Lavon, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

### SECTION 3. REPEALER CLAUSE

All ordinances or parts of an ordinance inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed. All other provisions of the ordinances of the City which are not in conflict with the provisions of this Ordinance shall remain in full force and effect.

### SECTION 4. OPEN MEETING

It is hereby officially found and determined that all notice required by law has been given and notice of this Ordinance was posted and the Ordinance passed in accordance with the Open Meeting Act.

#### SECTION 5. PUBLICATION

The City Secretary is hereby directed to publish notice of this Ordinance in accordance with applicable laws.

# **SECTION 6. EFFECTIVE DATE.**

This Ordinance shall take effect immediately from and after its passage and the publication of the caption, as the law in such cases provides.
