# A. Planning & Zoning Commission to review and discuss the Comprehensive Plan.

Commissioner Barnhart referred to the October 13, 2009 City Council Meeting and the item on the Agenda concerning reviewing all of the City Ordinances. His opinion was that the P & Z Commission should review and make recommended changes to Ordinances pertaining to them. Council Member Nabors asked if the list of the Ordinances could be provided to the Commissioners. City Manager Jones said he thought it would be a good idea to have a representative from the Commission at the next City Council Meeting. He suggested putting a discussion

Council Member Nabors asked that she be copied on any request that went before the Council on behalf of the P & Z Commission.
