IX. ITEMS FOR DISCUSSION

A. Planning & Zoning Commission to discuss Comprehensive Plan.

The Commissioners decided that it would prove less time consuming to go over the different elements of the Comprehensive Plan individually off line, pull the information, sort it and then review and discuss the information as a group.

Chairman Smith wanted the Commissioners to revisit the Vision of the Comprehensive Plan that was originally written in 2005. It was interesting to see

how the 2005 goals for schools and education, traffic and commuting, recreation and public space, residential growth and housing, commercial and retail, elderly services and community image and character were on target for the direction Lavon seems to be growing. The planners of that 2005 document had done a very good job.

Council Member Nabors discussed the City's vision, mission and goals with the Commissioners and encouraged them to review the documentation, attend council meetings and ensure synchronization with the Council and the EDCB as they move forward. Updated copies of the most recent draft will be provided to all Commissioners.

It was decided that the former Commissioners who had worked on the Comprehensive Plan would continue working on their previously assigned projects. Commissioner Hacking volunteered to work on an update to the public works section, and Chairman Smith said he would work with Commissioner Hacking.

Chairman Smith asked EDCB Chairman David Piekarski if he would be willing to provide feedback on the economic section to ensure its alignment with the vision of the EDC and its Board. Mr. Piekarski indicated he would be happy to do so.
