#### VIII. ITEMS FOR DISCUSSION

A. P & Z Commission to Discuss the possibility of opening a Residential Treatment Center for children. (Luis Sanchez, Guest Speaker)

Luis Sanchez and Fahisha Brown discussed the possibility of opening residential treatment service for children with emotional disorders that are currently in the custody of Child Protective Services. The facility would provide services that would meet each child's specific need whether they had been a victim of neglect or abuse. The children would attend public schools in the community.

Mr. Sanchez told the Commissioners that they were looking at a 2,847 square foot home in Lavon that would comfortably house thirteen children. The concern the Commissioners had was that they would have to redo the septic or aerobic system to handle the flow of waste water. They suggested that the Center might want to look at a house with acreage to accommodate that need or find a home on sewer.

The Commissioners reviewed the vision and goals of the center. They also suggested that Mr. Sanchez should meet with Community ISD and seek their input. They wanted to make sure the schools would also be ready to handle any special needs of the children.



B. P & Z Commission to Discuss EDC Board Element and establish a liaison to work with the Board. (Barnhart)

Chairman Smith told the Commissioners he had attended an EDC Board meeting and presented the element to them for their consideration and feedback. The EDC Board chose three members to review the element. They suggested that the P & Z Commission appoint a liaison to meet with them in an informal meeting.

EDC Member Chris Kane originally wrote the document. Council Member Deborah Nabors suggested that someone explain the P & Z's elements of the Comprehensive Plan to the Board and show how the EDC Board's input is important in determining what business they would like to see built in Lavon.

Commissioner Barnhart said he would be willing to meet briefly with the three EDC members chosen to review the plan. He felt that they should then be given a month to come back with questions and suggestions. Commissioner Barnhart said that he would also contact EDC Member Chris Kane. Chairman Smith also asked him to talk with Commissioner Rosenquist and see if he would be willing to help.
