Chairman Smith led the Invocation.

IV. ITEMS OF INTEREST/P&Z COMMISSIONS COMMUNICATIONS

Council Member Nabors told the Commissioners that on Thursday night, May 24th the Lavon Area Chamber of Commerce will be holding their Annual Awards Banquet at Grand Heritage Clubhouse from 6 pm - 8 pm. The Chamber will be recognizing community members, businesses and dignitaries.

Commissioner Bonney, Seat 4, said he would like to see the Comprehensive Plan finished, but then he would also not want to serve another two years. Commissioner Barnhart said he would also be willing to stay until the Comprehensive Plan was completed.

Commissioner Barnhart has been working with them explaining the priority of their input to the Comprehensive Plan. VII. ITEMS FOR CONSIDERATION AND ACTION

A. P & Z Commission to Consider and Act on Comprehensive Plan Elements. (Smith)

Chairman Smith handed the meeting over to Commissioner Barnhart to go over suggested changes to the following elements.

Commissioner Barnhart updated the Commissioners on the changed elements.

- 1. Parks & Recreation--Council Member Bodwell talked with Commissioner Barnhart. The Board is meeting and would like to have some input on the goals of this element. They have requested a P & Z representative or Board to meet with them.
- 2. EDC Element—Commissioner Barnhart met with an EDC Committee reviewing the element. They want to modify the element, but they have not responded to his email. Commissioner Barnhart also said that the EDC may extend an invitation to meet with the Planning & Zoning Commission.
- 3. Circulation Element—Commissioner Barnhart told the Commissioners that was still a work in progress.

Commissioner Barnhart also passed out a draft of a website layout for the Comprehensive Plan. It would include a definition of the plan, the need for the plan, differences between the plan and the P & Z Ordinance, principles of the plan, elements of the plan and plan maps.

Commissioner Bonney was given the list of the recommended changes the City Council made. He will incorporate the updates into the elements.

No action was taken.

X. SETTING FUTURE MEETINGS AND AGENDAS

Planning & Zoning Commission members and staff may request items be placed on a future agenda or request a special meeting be called. Each request that passes by a majority vote will be placed on the schedule by the City Secretary.
