VII. ITEMS FOR CONSIDERATION AND ACTION

A. P&Z Commission to Consider and Act on Comprehensive Plan Elements. (Smith)

The Commission discussed the Parks and Recreation Element of the Comprehensive Plan. It has been formatted to match the other elements of the Plan.

Motion: Commissioner Barnhart made a motion to accept this and send it to the City Council for review – version 0.3

Second: Commissioner Rosenquist

Discussion: Commissioner Cody asked about the Corp. of Engineer property being within the city limits and the number of parks in the city. City Manager Jones explained that there are 4 parks in the City. He further stated that the parks that surround Lake Lavon are within the City of Wylie. There was also question about the difference between the designation of park and open space being maintenance. City Manager Jones suggested making the definition of open space being one that is not improved instead of maintained and cautioned about just discussing public parks.

Commissioner Barnhart withdrew his motion.

City Manager Jones suggested that the Parks and Recreation Board join a future meeting to discuss this element. Chairman Smith stated that the Commission was moving forward with no action taken.

- B. P&Z Commission to Consider and Act on updating the Proposed City of Lavon Zoning Ordinance. (Rosenquist)

 It was suggested that a workshop be held specifically for working on this proposed ordinance and that comments about the ordinance be forwarded to Commissioner Rosenquist in order to be consolidated. Council Liaison Nabors suggested also copying the comments to City Manager Jones. No action was taken.
- C. P&Z Commission to Consider and Act on approving a draft Ordinance for the Lavon Code of Regulations to include the Planning & Zoning Commission. (Barnhart)
 City Manager Jones stated that on 3.3.1.1 (TLCG) should be (TLGC). Commissioner Barnhart stated that the revision date was wrong and should be 7/24/2012. City Manager Jones offered to make the corrections. Intake Clerk Wess questioned Item 3.3.1.2 (Commission Secretary) and if it could be worded similar to the Park and Recreation Board's Chapter. The Commission did not feel that, due to their high turnover rate, one of their members would be able to know all of the ins and outs of performing the job. No action was taken
