VII. ITEMS FOR CONSIDERATION AND ACTION

- A. Planning & Zoning Commission to Consider and Act on becoming skilled at remotely logging onto the City's Planning & Zoning Drive (Barnhart)

 Commissioner Barnhart presented a power point demonstration on how to use the Log-MeIn program in order for the Commissioners to use the City's server. It was discussed that the Commissioners only needed "read only" capabilities instead of having admin abilities. There was no action taken on this item.
- B. Planning and Zoning Commission to Consider and Act on procedures for amending and adopting the Comprehensive Plan. (Cody)
 Commissioner Cody had questions on what exactly the Commission was expecting in the way of procedures. The other Commissioners offered examples of different scenarios and what would be needed for each. No action was taken.
- C. Planning & Zoning Commission to Consider and Act on Comprehensive Plan Elements. (Smith)
 Commissioner Barnhart explained that he had not taken any further action on the power point presentation. He requested a version of the individual elements instead of the complete document to put on the website. No further action was taken.
- D. Planning & Zoning Commission to Consider and Act on updating the Proposed City of Lavon Zoning Ordinance. (Rosenquist)

 It was discussed that the Commission start with creating a matrix for the current zoning ordinance and possibly modifying the definitions. The discussion brought out that a matrix could show where modifications might be needed. It was also stated that it should only take 30 to 60 days to create the matrix.
