VII. ITEMS FOR CONSIDERATION AND ACTION

- A. Planning & Zoning Commission to Consider and Act on Comprehensive Plan Elements including, but not limited, to the future land use map and proposed industrial district regulations for the zoning ordinance. (Smith) Vice Chairman Barnhart stated he had met with the EDC and that they would like to see only light industrial in the City of Lavon. The EDC also recommended that industrial not be added to the legend on the land use map. They suggested going into the legend and changing commercial /business to commercial/industrial/business. Vice Chairman Barnhart relayed from an economic perspective the EDC consensus was that 50% of the revenue be residential and 50% commercial, with a third of that industrial. He asked the EDC how the 50% commercial and 50% residential acreage for the City would breakdown. The EDC stated that they would work on a breakdown of the acreage and the different percentages by zoning types. They would like to present it to the Planning & Zoning Commission for review. Vice Chairman Barnhart stated by the next meeting they needed to have the business and multifamily definitions written so the Ordinance can be written. He said no action would be taken on item A.
- B. Planning & Zoning Commission to Consider and Act on updating the Proposed City of Lavon Zoning Ordinance. Commissioner Rosenquist relayed he worked on the Matrix and put it in alphabetic order. He said it became apparent that there are several duplications. Vice Chairman Barnhart suggested changing the X's into P and S for Permitted and Special Permit. He confirmed that Gaming and Tobacco Sales needed to be added. Commissioner Rosenquist stated he would put a legend on the map. Vice Chairman Barnhart said no action would be taken on item B.

Vice Chairman Barnhart stated item A Comprehensive Plan Elements and item B updating the Proposed City of Lavon Zoning Ordinance needed to be added to the next Agenda.
