VII. ITEMS FOR CONSIDERATION AND ACTION

A. Planning & Zoning Commission to Consider and Act on Comprehensive Plan. (Smith) Chairman Smith relayed that the Plan had been approved at the previous City Council meeting. Council Member Nabors stated that there were minor changes made to the Plan. Chairman Smith said that there was no action to be taken on item A.

B. Planning & Zoning Commission to Consider and Act on updating the Proposed City of Lavon Zoning Ordinance. (Rosenquist)

Commissioner Rosenquist stated he did not have time to work on the matrix but he did research the light industrial definitions. City Secretary Wess confirmed some of the light industrial is already in the City's business zoning. Commissioner Rosenquist related he could add an "L" on the matrix on the ones that were already in there. He asked if the Commissioners want to change the existing categories, or take the ones now and get them approved, and then move on to expanding them. Chairman Smith made a recommendation that whatever the potential list of businesses would be that the Planning & Zoning pass those to the EDC and let them look at it. He said they might want to move some of the B1 and B2 over to light industrial. The Commissioners discussed the different uses for the Businesses in Lavon. Chairman Smith stated no action to be taken on item B.
